Ronald Noble, FBI & all employees of ICC,

Hereby you receive extra evidence about corruption & favourism by the Police Bloemendaal.

On 31 october 2008 I pressed charges with the local Police Kennemerland-Bloemendaal against the housing-association WBVBrederode and a local plumber F. Van Baak .

Cause:

- WBVBrederode ignores the existence of local crime. I can not report criminal behavior of a plumber in my house. WBVBrederode wants friendship with the local plumber at the cost of the legal position of the renter. The arbitration-commission 'Regionale Commissie Woningcorporaties' accepts my complaint but doesn't proceed on it = they don't work, probably have no staff
- F.van Baak refuses to accept complaints about an aggressive plumber in my house = I have to pay the bill as if nothing happens. Van Baak refuses to wait for the report of the Regionale Commissie Woningcorporaties on my complaint against WBVBrederode. He wants money.
- Both organisations are located in my neighbourhood.

The Police ignores me completely = my letter & emails. I can't print a copy of the emails.

What happens?

The local Police-officer in charge is the one who mentally tortured me on command of major Wim de Gelder. He receives all mail from PO box 57 Police Kennemerland.

When he wants a specific file / charges to disappear, he simple removes them from the office. I can't complain with the head-office, they are corrupt too.

The Police Bloemendaal only works on command of the local council.

THUS...? I have No rights, No protection....

Consequences:

The millionaires have to be extra protected against crime according to major Wim de Gelder.

He wants an individual Security-plan for every residence.

These houses need to be protected by extra local Police-officers.

These Police-officers are the ones who mentally torture the poor; who turn the housing-association for rental-homes into a corrupt-construction... together with some local entrepreneurs.

Millionaires are at extra risk when they have the local council for security = poor 'will try out crime, to see if the council & police is smart enough to stop crime'.

When millionaires in Bloemendaal want protection, they'd better make up their individual plan with a Security-compagny, and add a confidentially-code to the contract.
